# Viskase Website Privacy Policy—Mexico

Viskase respects your concerns about privacy and values its relationship with you.

This Privacy Policy applies to information collected by Viskase Companies, Inc. with address at 333 East Butterfield Rd. Lombard, IL 60148-5679, USA and its affiliates and subsidiaries ("Viskase," "we," or "us"), including, but not limited to all websites or apps that post a link to this Privacy Policy (collectively, "Sites").

This Privacy Policy explains how we collect and use personal information that you provide to us and that we collect about you when you visit our Sites, as well as your choices regarding the use of that information.

Because Viskase operates globally, we have developed privacy policies that take into consideration the various regulations and frameworks governing the collection, use, disclosure, sharing and disposition of personal information. **This Privacy Policy applies to users in Mexico.** 

#### **CONSENT TO PRIVACY POLICY**

By using the Sites, you are agreeing to the practices described in this Privacy Policy and you expressly consent to provide all personal data to Viskase through the Site, as well as to processing for the purposes indicated in this Privacy Policy and subject to the Terms of Use that apply to the Sites.

#### CHANGES TO THE PRIVACY POLICY

We ask that you read this Privacy Policy from time to time. We may modify it at any time in our sole discretion. If we make material changes to this Privacy Policy that increase our rights to use personal data that we have previously collected about you, we will obtain your consent, where required by law, either through your registered email address or by prominent posting on this Site.

## INFORMATION WE COLLECT

We collect personal information about you when you interact with our Sites, including when you join a mailing list. The personal information we collect is the following:

- Name
- Title
- Email address
- Phone number
- Company name

- Address
- Shareholder status
- Bondholder status
- Information that you choose to submit in connection with a credit application or other communications that you send to us

## INFORMATION WE AUTOMATICALLY COLLECT

We automatically collect information about the devices you use to interact with our Sites, as well as information about how you interact with the Sites. The information that we automatically collect includes the following:

- IP address (and other device identifiers)
- Web browser type and version
- Website that referred you to the Sites
- Content you search for on the Sites
- Pages you visit while on the Sites

The information that we automatically collect will be associated with any personal information you have provided.

#### CHILDREN'S PRIVACY

Our Sites are general audience Sites not directed at children under the age of 18. If we obtain actual knowledge that any information we collect has been provided by a child under the age of 18, we will promptly delete that information.

#### HOW WE USE YOUR PERSONAL INFORMATION

We use the personal information that we collect about you and that you provide to do the following:

- Manage everyday business needs, such as administration and improvement of the Sites

- Prevent fraud
- Enforce the Terms of Use
- Comply with all applicable laws and corporate reporting obligations

We may also use the personal information we collect about you for the following voluntary use, to which you may oppose:

#### DO NOT TRACK

Our Sites do not collect personal information about your online activities over time and across third-party websites or online services. Therefore, "do not track" signals transmitted from web browsers do not apply to our Sites, and we do not alter any of our data collection and use practices upon receipt of such a signal.

## **BUSINESS STRUCTURE CHANGES**

We reserve the right to disclose and transfer all information related to our Sites, including personal data, if you do not oppose to this in terms of the section "How to Contact Us" below:

- To a subsequent owner, co-owner, or operator of one or more of the Sites; or
- In connection with a corporate merger, consolidation, or restructuring, the sale of substantially all of our stock and/or assets, or other corporate change, including, during the course of any due diligence process.

#### INFORMATION WE SHARE

We share your information with third-party service providers who perform services and functions on our behalf to support our interactions with you, including, for example, providing our products and services, processing your purchases, hosting product reviews, or communicating with you. These third parties are not authorized by us to use or disclose the information, except as necessary to perform services on our behalf or comply with legal requirements. These third parties have no independent rights to the data.

In addition, we will disclose information about you to law enforcement authorities other governmental officials, other authorities and other entities of the group:

- If we are required to do so by law or legal process
- When necessary to comply with legitimate requests related to an investigation
- When we believe disclosure is necessary or appropriate to prevent physical harm or financial loss or in connection with an investigation of suspected or actual illegal activity
- If necessary to protect the vital interests of a person
- To enforce our Terms of Use
- To protect our property, services, and legal rights

- To prevent fraud against Viskase, our affiliates, business partners, or authorized dealers
- To support auditing, compliance, and corporate governance functions
- To comply with any and all applicable laws

## HOW WE MAY USE COOKIES AND OTHER TECHNOLOGIES

When you visit our Sites, we may place pieces of code, commonly referred to as "cookies," or use similar technology (such as web beacons) on your devices. Where permitted by law, we may begin collecting information as soon as you visit the Sites.
